

WRITTEN AGREEMENT

1. ACKNOWLEDGEMENT

In connection with my affiliation with the AR Program under the Selected Reserve Incentive Program, I hereby acknowledge that:

a. I meet the eligibility criteria, as follows:

(1) I am currently serving in the regular component and have 180 days or less remaining on my active duty (AD) obligation. Or I have served in the regular component, Active Reserves (AR) or Selected Marine Corps Reserves (SMCR) and I have no more than a 3-year break in service from being released from the regular component, AR or SMCR under honorable conditions. \_\_\_\_\_ Initial

(2) I have been accepted by CMC (RAM-3) to affiliate with the AR program by 30 September 2012. \_\_\_\_\_ Initial

(3) I am eligible for at least 36 months reenlistment or voluntary extension. \_\_\_\_\_ Initial

(4) If I am currently a member of the SMCR, I am a satisfactory participant. \_\_\_\_\_ Initial

(5) I am affiliating with the AR Program for a period of 3 years and qualified in Primary Military Occupational Specialty (PMOS) \_\_\_\_\_ as listed in the current AR EAB MARADMIN. \_\_\_\_\_ Initial

(6) I am a Corporal or Sergeant, and I have not been reduced in rank to my current grade except as a requirement of MARADMIN 362/11. If a Sergeant, I have not been passed over for promotion to Staff Sergeant or I have not been selected for promotion to Staff Sergeant. \_\_\_\_\_ Initial

(7) If affiliating in a non-aviation MOS, I have at least 30 months of Active Duty in eligible MOS. If affiliating in an aviation MOS, I have no less than 4 years of Active Duty in eligible MOS. \_\_\_\_\_ Initial

(8) I am not entitled to receive retired or retainer pay. \_\_\_\_\_ Initial

b. I will serve satisfactorily, as prescribed by the appropriate regulations of the Selected Marine Corps Reserve, the complete affiliation period in the AR Program according to my written agreement and in the PMOS in which affiliated, unless excused for the convenience of the Government. \_\_\_\_\_ Initial

c. If I am a Corporal, I will receive a \$10,000 lump sum payment upon affiliation. If I am a Sergeant, I will receive a \$10,000 lump sum payment upon affiliation with an additional \$5,000 soon thereafter for a total of \$15,000. \_\_\_\_\_ Initial

d. I understand that recoupment of the bonus will be calculated in accordance with paragraph e below if:

- (1) I fail to fulfill the obligation. \_\_\_\_ Initial
- (2) I execute a lateral move. \_\_\_\_ Initial
- (3) I augment to the Regular Component. \_\_\_\_ Initial
- (4) I transfer to the SMCR, IMA or the IRR. \_\_\_\_ Initial

e. Recoupment. I understand that this incentive will be recouped at a prorated amount and recoupment will be computed as follows:

(1) The number of months served satisfactorily during the affiliation period for which the bonus was paid multiplied by the monthly bonus amount (\$277.77 for a \$10,000 bonus, \$416.67 for a \$15,000 bonus) then subtract this amount from the total bonus paid. \_\_\_\_ Initial

(2) If recoupment occurs, I am no longer entitled to future incentives. \_\_\_\_ Initial

f. Termination from bonus entitlement will not affect my period of obligation to serve the remainder of my Military Service Obligation in the Ready Reserve. \_\_\_\_ Initial

g. Recoupment will not occur if:

(1) I am denied further service due to twice failing selection to the next higher grade or disability. \_\_\_\_ Initial

(2) I accept a commission or an appointment in the Reserve Component and have served more than 1 year of the incentive obligation. \_\_\_\_ Initial

2. Understanding. I understand each of the statements above and understand that they are intended to constitute all promises or commitments made to me in conjunction with my affiliation. I have been issued a Bonus Control Number (BCN) \_\_\_\_\_, and I further understand that without a BCN I am not entitled to this incentive. \_\_\_\_ Initial
